REGULATION

ON THE CALCULATION AND PAYMENT OF INCENTIVES

1. This regulation determines the order and conditions of calculation and payment of additional rewards to the employees of the National University of Architecture and Construction of Armenia (hereinafter - NUACA) for the execution of certain types of work.
 - 1.1 Employees of NUACA shall be paid additional incentive fee for the performance of certain types of research, educational and organizational work in accordance with the procedure and amounts established by this regulation.
 - 1.2. In case of deliberate falsification of data necessary to receive additional payments specified in this order, the employee is deprived of the right to receive additional payments in accordance with this order for a period of 3 years.

2. REGULATION ON THE CALCULATION AND PAYMENT OF INCENTIVES FOR INDIVIDUAL TYPES OF RESEARCH ACTIVITIES

2.1. Additional remuneration is paid to NUACA staff for selected research activities as per table 1.
